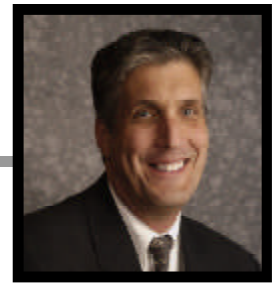


CORPORATE RESUMÉ

Mr. Creaser's career started in 1978 with Speedie & Associates predecessor firm, Halpert Associates (which became Speedie & Associates in 1980), where he worked on a part time basis while attending Arizona State University. From 1978 to 1983, Mr. Creaser had varied duties with an increasing level of responsibility, including Laboratory Technician, Survey Technician, Field Technician, ultimately becoming Laboratory Manager by 1983. Mr. Creaser became a full-time employee in 1983, and at that time assumed Senior Field Technician and Special Inspector duties on several large-scale construction projects. In 1984, Mr. Creaser received his Bachelors of Science Degree in Civil Engineering, at which time was elevated to Field Services Manager, where he performed and supervised extensive field and laboratory testing and inspection of construction for many major civil and public works projects, transportation projects, commercial/industrial, school and hospital projects. In 1987, Mr. Creaser became a Registered Professional Engineer in the State of Arizona, and continued his technical and administrative duties within the Field Services Division, as well as planning, promoting and leading the Divisions growth. He was promoted to Corporate Vice President and became a minority shareholder in 1995, and continued to actively participate in the planning, operation, and growth of the firm. In February of 2001, Mr. Creaser, in concert with the three division managers, purchased the firm from its founders. Mr. Creaser is now a major shareholder and principal of Speedie & Associates.
